**Semi-annual assessments were due September 1, 2021 and are now past due.**

**Please note –**

**Pedestrian Gate:** It was found the keypad for the pedestrian gate was not functioning properly. It is repaired and uses the same code as previously. Please ensure your children use the pedestrian gate for their safety.

**ARC:** Submit and wait for approval of ARC applications before beginning any exterior changes. Please also see ARC Review guidelines sent you last month for examples of the most common exterior modifications for clarifications.

**Property Cleanup –** Letters have been mailed to clean up around properties and take care of minor repairs. Please clean up by power washing homes, fences and driveways as needed. Please remember regular mowing, edging and pest control.

**Garbage:** As a reminder, garbage and recycle carts are to be kept out of sight of the street and put out on day of pickup as well as put away on day of pickup.

**Parking –** As a reminder – there is no parking on the grass (non-paved areas) anywhere in Regency Place. There shall be no vehicles on the street between hours of 11 pm and 7 am. While you may park on the street during the day, please remember to fill out an overnight parking form for the pool lot for overnight temporary parking. Vehicles are towed. If vehicles are towed, call Webb's towing at 863-967-2354 as posted at the front of community.

**Pool Parking –** A few of the parking spots will be utilized during construction of the storage building which will cut down on the already limited overnight parking spots for the pool area. Please be aware it is first come first served at the pool parking lot and you may be asked to make other arrangements due to no availability.

**Pool –** All posted rules are from the Polk County Health Department to be followed for the pool to remain open. All children under 16 must have an adult to supervise them inside the pool area. Opening time is 8 am and closing time is sundown (time varies with time of year). You will find the time posted inside the pool area as the pool auto locks at the current posted time. Pool closes early at 6 pm on the monthly 17th HOA meeting dates or other occasional meeting dates as posted.

**Regency Place Streets -** Navigating through Regency Place include speed humps, exit gate spike strips and winding streets. Posted speed is 15 mph to accommodate visibility issues of winding streets for safety of walkers and children at play. **Tips** for going over spike strips – come to a complete stop before spike strips, after gate opens fully take foot off brake and roll slowly over spike strips. Do not back up! Drive slowly over speed humps and spike strips to avoid damages to vehicles. The HOA is not responsible for damages involving failure to follow posted signs regarding speed humps and spike strips.
